WALLAROO CODE AMENDMENT INFORMATION SHEET

A Code Amendment (or 'rezoning') is being sought on land located between Spencer Highway, Bowman Road and Rosslyn Road, Wallaroo ('Affected Area'). The Code Amendment seeks to rezone a portion of the Affected Area to the Employment Zone and a portion to the Neighbourhood Zone.

The rezoning will provide employment land supply to support employment growth in the Region and the Neighbourhood Zone will create a logical extension and connection between existing residential land.

The Code Amendment is being proposed on the basis that:

- Wallaroo is a key township for the Mid North and Yorke Peninsula Region
- The population in Wallaroo and the Region is growing
- There is a need to provide commercial and residential zoned land to support the growing population

PROPOSED ZONING CHANGES

CURRENT

RURAL ZONE

Supports the South Australian economy primarily through the production, processing, storage and distribution of primary produce, forestry and renewable energy. The Zone also supports value adding businesses such as industry, primary produce, tourist development and tourist accommodation.

PROPOSED


NEIGHBOURHOOD ZONE

Allows for housing which supports a range of needs and complements the existing and local character, together with some small scale supporting uses (such as small scale shops, offices or community facilities).


EMPLOYMENT ZONE

Allows for a diverse range of low-impact industrial, commercial and business activities that complement the land uses of adjoining zones.
